Uploading Your COVID-19 Vaccination Record Through The Employee Information System (EIS)

IMPORTANT NOTE: Before beginning, please make sure that you have a clear and readable image of your COVID-19 vaccination record on the device (computer, phone, or tablet) you are using to access EIS and that your name and vaccination dates are visible. Acceptable vaccination records include:

- Picture or scanned image of your COVID-19 Vaccination Record card
- Picture/screenshot or scanned image of a COVID-19 QR Code/Vaccination Proof from the California Department of Public Health (CDPH), your health provider, or pharmacy where you received your vaccination

1) Open up an internet browser and go to https://employee.ocde.us
