Subject: 2012-13 Third Quarter Lottery Apportionment

The 2012-13 third quarter lottery apportionments were distributed by the State Controller's Office on June 25, 2013. The apportionment was certified at \$33.74 (\$33.739820268) per unit of average daily attendance (ADA) for the unrestricted lottery apportionment and \$5.86 (\$5.855957024) per ADA for the Proposition 20 restricted apportionment. The total combined (unrestricted and Prop. 20) apportionment paid to date for the 2012-13 fiscal year is approximately \$107.45 (\$107.446907136) per ADA.

It is worth mentioning that the current year lottery apportionments to date are less than the 2011-12 lottery apportionments for the first through third quarter by \$7.38 per ADA unrestricted and \$8.09 Prop. 20 restricted for a combined total decrease of \$15.47 per ADA.
