Subject: 2013-14 Second Quarter Lottery Apportionment

Second quarter lottery apportionments were distributed by the State Controller's Office on March 28, 2014. The apportionment was certified at \$42.66 (42.664055739) per unit of average daily attendance (ADA) for the unrestricted lottery apportionment. The total unrestricted lottery apportionment for the 2013-14 fiscal year paid to date is \$80.57 (\$80.570927591) per ADA. It's worth mentioning that current year lottery apportionments to date are more than the 2012-13 lottery apportionments for first and second quarter by \$12.72 per ADA or 18.75%.

For budgetary purposes, the CDE recommends that school districts budget \$126 per ADA for unrestricted lottery and \$31 per ADA for restricted lottery. The restricted "Proposition 20" portion for the current year will not be made available until the third or fourth quarter when the growth in lottery revenues for the year will be known.

Enclosed is a worksheet that summarizes the total 2013-14 second quarter lottery apportionment. Additionally, the Lottery Educational Apportionment System Master Register is available online at the State Controller's Office website: http://www.sco.ca.gov/ard_payments_lottery.html
