NEW BUSINESS PROGRAM UPDATES

- Enrollment Updates
 - o We currently have 152 students enrolled and 82 graduates
 - We just graduated our 100th student!
 - Our grad rate continues to increase
 - We will be celebrating our grads next week with grad photos and cap and gown distribution
 - Graduation is on June 9 at 5pm at La Habra High School Theater
 - Victor Rios will be our guest speaker at graduation
- Admin Office Updates
 - o Our lobby wall designs will be installed next week

WIOA Grant Updates

- We received the grant award letter but have not yet received the allocation (funds go through 2027)
- We will use this grant to fund two transitional specialists for incarcerated students, and one coordinator to support the grant funding
- o We expect to have three teachers serve approx. 125 students
- o An offline LMS system will be utilized by the students

• CAJC Ending Ceremony

- o On June 1, *The Freedom Writers Diary* movie will be shown to students and they will also receive a copy of the book
- o On June 2, Darrius Garret, co-author and a member of *The Freedom Writers Diary* will speak to the students

BOARD DISCUSSION

Local Control Accountability Plan (LCAP)

- Presentation
 - o Goal 1, Engagement
 - Requesting \$100,000 for marketing efforts to increase enrollments - CCPA was recipient of four awards for website videos
 - This year, 34 student events were held, including several with partner Working Wardrobes
 - New dry-good pantry will open in the Fall of 2023
 - o Goal 2, Pupil Outcomes
 - We will continue to fund our Community Resource Specialist, who helps 32% of our students who need assistance
 - New contract with Christie Campus Health that will offer 24/7/365 counseling and wellness services
 - New contract with Tutor.com that will provide 24/7/365 tutoring assistance
 - o Goal 3, Conditions of Learning
 - We continue to support our English Learners and will be purchasing new curriculum in the coming months
 - EL proficiency rate is 30% this is higher than the State rate, the County rate, and OCDE's rate
 - In the first semester, 120 students were enrolled into Edgenuity (LMS platform), in 291 classes, averaging 43 hours of online work, 86% progress rate, 75% graduation rate, and a 73% completion rate
 - 28 students graduated from the California Job Challenge program
 - All staff are participating in a 3-year MTSS course and just completed the first year
