## **Eligible Students**



Substandard housing: without sufficient access to plumbing/electricity, physical space \*Does not meet the physical, phycological and emotional needs of students: security, safety, privacy, achievement, connection...

"(ii) children and youths who have a primary nighttime residence that is a <u>public or private place not designed for</u> <u>or ordinarily used as a regular sleeping accommodation</u> <u>for human beings</u> (within the meaning of section 103(a)(2) (C)); "(iii) children and youths who are living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings"

"children and youth who are living in motels, hotels, trailer parks, or camping grounds due to the lack of alternative adequate accommodations"

"...individuals <u>who lack a fixed, regular, and adequate</u> <u>nighttime residence</u> (within the meaning of section 103(a) (1)); and (B) includes — (i) children and youths who are <u>sharing the housing of other persons</u> due to loss of housing, economic hardship, or a similar reason;"

Federal legislation passed in 1987

Supports educational rights of children and youth

- experiencing homelessness
- 2002: No Child Left Behind
- October 2016: ESSA: "Every Student Succeeds" Act

## **Educational Rights**

- Placed in least restrictive school setting
- May enroll w/o transcripts, *immunizations*\*
- records, or similar records. The Liaison should be

- •\*Federal law over-rides CA. State and local law
- Transportation assistance
- •Fee waivers for participation in school activities
- Immediate enrollment in all school meal
- programs
- ·Partial or full credit given for work completed
- •Transfer school records w/in 2 business days



# **Barriers & Challenges**

### School placement changes

Lack of social connection/inclusion to site, peers, teachers, and staff

### Transportation

Based on what is offer district to district, i.e. bus passes, pick-up and dropoff, gas cards etc.





### **Enrollment Requirements**

- Establishing residency
- School records
- Immunizations
- Legal Guardianship
- Potential fees/fines

- Potential trauma
- Food Insecurity
- Lack of school supplies, clothing, etc.
- Unmet medical. dental. and/or mental health needs



# **Liaison Responsibilities**

- Remove Educational Barriers (proof of residency and/or school records)
- Rights to Immediate Enrollment / Post Educational Rights / Provide Outreach /Dispute Resolution Policies
- Actively identify and record students who qualify (student information systems & CALPADS and CARS
- Seek and maintain necessary paperwork for academic support, enrollment, and future SUCCESS
- Participate in establishing school of origin or school of residence
- Assist with development of transportation plan and Free Reduced Lunch (FRL) Program
- Ensure students/families know their education rights/ Unaccompanied Youth, Partial Credits, AB 1806, Access to Higher Education

- Monitor school attendance; support academic and social success – Child Welfare Attendance (CWA)
- Collaborate with partners in providing services/within your LEA: Title I Coordinator, LCFF/LCAP, School Administrators,
  - Office Supervisors, Registrars, CWA, SARB, Community
  - Liaisons, Nutritional Services, Health & Wellness,
  - Counselors, Special Education, After School Programs AB
  - 1567 Priority Enrollment, and Transportation Services, Federal Program Monitoring (FPM)
- ESSA Requirements provide homeless educational rights, sensitivity trainings to all school personnel: administrators, office staff, registrars, teachers, nutrition, health & wellness, community liaisons, school psychologists, counselors, bus drivers, preschool/after school staff, custodians, etc.

## **Liaison Responsibilities - DATA Systems and Reports**

Data collection begins at the school and LEA level. Each LEA has a local liaison for homeless education who is responsible for ensuring the identification of homeless students through coordinated activities with other school personnel and community agencies (42 United States Code [U.S.C.] § 11432[g][6][A][i]).

The liaison is also responsible for working with the LEA's data staff and the State Coordinator to ensure the LEA provides accurate data that meets the required elements outlined by the Secretary of Education.

All LEAs are required to report the number of homeless students enrolled at any time during a school year through the CALPADS, annually

CALPADS is the longitudinal data system used to maintain individual-level data including student demographics, course data, discipline, assessments, staff assignments, and other data for state and federal reporting



# School of Origin Rights

School attended when permanently housed

School attended within last 15 months to which they feel most connected

Includes designated feeder school for the next grade level

School placement also determined by "student's best interest"

Once student obtains permanent housing, transportation to school must be provided until the end of the academic year, if in the best interest to remain in that school





- School siblings attend
- Transportation availability
- •Length of anticipated stay in current location
- •Special Programs
- •Number of School placement changes in past
- •Connection with extracurricular activities

# **CALIFORNIA LEGISLATION**

•SB 177 Homeless Youth Education Success Act (EC 48850,48852.5): homeless students automatically meet residency requirements, requires immediate enrollment, LEAs must ensure public notice of educational rights

•AB 309 CalFresh Assistance HY (WIC 18904.25, WIC 18901): No minimum age for unaccompanied youth to access CalFresh

•AB 652 Child Abuse and Neglecting Act (Penal 11165.15): Child/youth classified as homeless is NOT a sufficient enough a reason file a child abuse or neglect report

•AB 1567 Before & After School Priority: Gives 1st priority enrollment in After School Education & Safety (ASES) to homeless youth, and require program to inform the parent/caregiver priority enrollment and how to request priority enrollment

•AB 1733 Fee waiver for birth certificate and California ID card for Homeless Children & Youth: with appropriate documentation, homeless children and youth can request a fee waiver to et a replacement birth certificate and a California ID card.

•AB 1806 Pupil Services (EC 48915.5, 48918.1, 51225.1, 51225.2): Requires LEA to notify homeless liaison of manifestation determination meeting, a suspension hearing, or expulsion hearing of homeless youth AND exempts homeless student from completing graduation requirements in excess of state graduation requirements if s/he transfers after 2nd year of high school

•SB 252 No Cost Assessment for Homeless Children & Youth: Prohibits CDE from charging fees to administer the CHSPE and the HSE to a homeless child or youth who is under 25 years of age and can verify status as homeless child or youth

•SB 445 Residence: Allows homeless student to continue in matriculation/feeder patterns between grade levels- elementary- middle-high school

•SB 177 Participation Interscholastic Sport or Extracurricular Activities: Student immediately to meet residency requirements





# AB1806 (McKinney-Vento)

California assembly bills which exempt students who qualify from local graduation requirements







•Student has transferred after their 2nd year in high school and cannot reasonably graduate in the traditional four years •Student must be in foster care or identified as McKinney-Vento at the time of qualification

- •Meeting must take place within 30 days of identification •Ed Rights holder must be involved in the decision making process
- •All options must be presented
- Review of progress happens at every quarter
- •Contract follows them to future schools
- •Student can change their mind at any time
- •The reduced credits is reflected primarily in electives •Student receives a traditional diploma and is eligible for to

apply for FAFSA







# **AB27 Housing Questionnaire**

Effective October 2021, California law requires school districts, county offices of education and charter schools to administer an annual housing questionnaire and report the results every year to the California Department of Education.



**Create various formats** of the questionnaire, paper based, virtual PDF, QR Codes, websites, handbooks and annual notices should be sent, back to school, open house, PTA, and other departments like nutritional services
